On Tuesday, May 12<sup>th</sup>, we informed you that we would be testing some of our Residents and Associates for the presence of the coronavirus. We have now received the results. Of the 75 Residents and Associates who were tested, two Residents were found to be positive for the presence of the coronavirus. All other Resident and Associate test results were negative, showing no presence of the coronavirus.

Both Residents were already in quarantine in our Observation Accommodations and have now been transferred to our COVID Accommodations. We will continue to monitor them and the rest of our Residents and Associates for any signs and symptoms of COVID-19 (including a fever and respiratory symptoms).

On Saturday, May 17<sup>th</sup>, we also admitted one guest to our COVID Accommodations bringing our total of those being served in these specialized accommodations to four (4).

The Centers for Medicaid and Medicare Services (CMS) requires that we provide you with updates on our number of Residents and Staff members who have been affected by COVID-19. In addition, LifeStream has been committed to honesty and transparency since the outset of this pandemic.
