SUBJECT: Taking Small Steps
Forward Together –
Chapel Services

As we continue navigating life with the coronavirus, we want to take small steps with you, as we cautiously step forward together – back to Community with one another. Each of our Independent Living communities has a few plans in the works that we'll be communicating to you over the next few weeks.

Here at LifeStream at Thunderbird, we are excited to announce our first step forward will be Chapel Service. Our team has been hard at work planning and preparing for a safe and welcoming service. Led by Chaplain Chuck, the service will occur on Wednesday afternoons at 2 p.m. – with our first service being this Wednesday, August 19. Because each event will be safely socially distanced, there will be a limit of 17 participants.

Day and Time:

Wednesdays at 2 p.m. (RSVP required by 4 p.m. the Tuesday before. To RSVP call the Front Desk at 602-938-5500).

Instructions for Attending:

1. Everyone must be wearing a mask & must not have flu-like symptoms.
2. There will be a welcome line set up at the chapel doors. We will:
 - i. Check your reservation/RSVP.
 - ii. Take your temperature and ask health screening questions.
3. All participants will be asked to sanitize their hands at the provided hand sanitizing station upon entry to our sanitized Chapel.

4. Each participant will have their own pre-sanitized chair, or spot marked on the floor. We ask that everyone stay in this designated spot for the duration of the chapel service.
5. We are unable to provide communal snack and beverages (due to required infection control protocols).

To reiterate from our earlier communication, you are not required to participate in any of the planned activities. You have the choice to participate to your and your family's comfort level. For this, and other socially distanced, congregant activities, participants will be asked to complete a waiver acknowledging the risks associated with such activities. We will continue to observe our ongoing safety guidelines: observing a 6' (socially distant) *Comfort Zone*; wearing masks at all times; and, sanitizing hands prior to activities.

As your trusted community, it is our desire to continue to share with you and your family the latest guidance from Public Health. Our goal is to continue to help keep you and your loved ones safe, and help you make informed decisions about your health and wellbeing.
